#### Introduction and Needs Assessment

## About Trauma

Trauma is a disease; its prevention is crucial and saves lives. Berwick et al. (2016) highlighted that the innovation in trauma care has accelerated, spurred by the significant burden of injury. During recent wars, the percentage of wounded service members who died in the line of duty decreased from %23 to %9.3. Effective bleeding-control measures, improved resuscitation techniques, and aggressive neuro-critical care interventions are among many advances that saved lives on the battlefield (Berwick et al., 2016). These advances do not only affect the battlefields, in fact, the journey in trauma is a war zone close to home.

Rapid industrialization and urbanization in low- and middle-income countries (LMICs) have shifted the focus of the global burden of disease toward trauma (Callese et al., 2015). Murray and Lopez (1996) predicted that road traffic incidents was moving from the 9th leading cause of death in the 1990s to the 3rd in 2020, which became a fact as proven by the WHO and CDC studies. The shifting of disease epidemiology toward acute illness and trauma has made the development of emergency medical services and trauma service (EMS and TS) systems a national public health priority in several countries, especially low and middle income ones (Callese et al., 2015). Traumatic injury causes, and its subsequent diagnoses and procedures were significantly changed by the pandemic. During times of pandemic related restrictions including shelter-in-place and social distancing orders, hospitals must prepare for more than the potential demand of an influx of infected patients (Salotto et al., 2021).

Trauma systems in resource-rich countries have decreased mortality for trauma patients through centralizing resources and standardizing treatment (Callese et al., 2015). An ideal trauma system includes all the components identified with optimal trauma care, such as prevention, access, prehospital care and transportation, acute hospital care, rehabilitation, and research activities (Committee on Trauma, 2014). The development and implementation of national norms or guidelines for trauma care have been advanced by emergency, pre-hospital, and trauma communities.

Observations and studies conducted since the late 90s and early 2000, indicate a reduced frequency and risk of death in states with established trauma systems (Hedges et al., 2002). Since then, studies have been conducted in areas with rural care and level III trauma systems, and major improvements have been detected and documents with the established standardized trauma guidelines, education, certification, and trauma systems implementation. An estimated 1000 to 2000 lives were saved by widespread correct use of the tourniquet (Berwick et al., 2016). Thus, what would a more holistic system do?



Some of the countries built on pre-existing systems, others started from scratch. Some of the initiatives undertaken were; extensive and intensive training of the EMS, increase funding to EMS and TS, improve dispatching systems, comprehensive needs assessment, establishment of trauma registries, involvement of key shareholders and the limitations are many.

#### Trauma Registries

Research on the quality of trauma registries is scarce. Data in trauma registries need to be reliable when used for evaluation of injury management, trauma protocols and hospital statistics. Maintaining a high level of accuracy and consistency within the registry poses a challenge when many people are involved in the registration process (Horton et al., 2017). Inaccurate or incomplete documentation lead to problematic indexing and coding, and negatively affects the registrar and the quality of the trauma registry and limits its efficient use.

#### Post-Trauma Care

Most studies of quality of life after injury have been performed with severely injured patients. Recovery after minor injury remains an unexplored area although a greater proportion of trauma results in minor injury. Minor trauma can lead to medical costs, loss of income, and psychological symptoms that can interfere with everyday life and prevent patients from returning to preinjury level of functioning (Nasirian et al., 2020).

Trauma patients suffer from physical and emotional impairment such as remaining in pain, stress and anxiety up to several years after the trauma, which emphasizes the importance of post-trauma follow-up (Llaquet Bayo et al., 2018; Stergiannis et al., 2014; Wad et al., 2018, as cited in, Nasirian et al., 2020).




## **Description Of The Event**

The above-mentioned highlight the importance of Trauma awareness, education, systems, registries, and multidisciplinary collaboration. COVID19- pandemic did not make this complex disease management easier. In 2020, the Academy of Sciences (AOS) identified the need to maintain a global network to address Trauma at all levels. ALTC 2020 was a great success; more than 200 leaders chaired sessions and addressed more than 3,000 healthcare providers and pioneers joined from 50 countries worldwide. The feedback and level of satisfaction was huge. ALTC 2021 aims to address Trauma at all levels amid a pandemic, taking into consideration the limitations and the global needs for comprehensive, low cost, efficient, and reachable trauma systems and registries, while addressing Trauma quality and appropriate measures to put in place for an improved system. The activity will be virtual, using a 3D virtual platform to bypass the pandemic and travel limitations and reach out to healthcare providers from all specialties, at all levels, from all the globe. It will be conducted over 3 days with 5 parallel sessions, on November 6-8, 2021 (starting at 15:00 Riyadh time, GMT+3) and will be submitted to local and international accreditations.




